

1. The testing regulations listed below will be strictly enforced. It is test takers' responsibility to read and fully understand the instructions and requirements. If before, during, or after the test you do not comply with testing regulations and the instructions given by test supervisors, you must leave the test site. Your test will not be scored, the test fee will not be refunded, nor can the test be rescheduled.

2. On the day of the test, please ensure that you bring with you an acceptable form of identification, medium-soft black (2B) pencils and erasers.

3. In order to enter the test site on the day of the test you must present an acceptable form of identification. Acceptable forms of identification include:

Test takers of 16 years and above: R.O.C. identity card or valid passport. Copies are not accepted.

Test takers younger than 16 years: R.O.C. identity card or valid passport. Copies are not accepted. If a test taker in this group does not have an identity card or passport, test taker may present a health insurance IC card with printed photo (cards without a photo cannot be accepted).

Foreign nationals (non native English speakers only): Valid passport or ARC.

If you fail to bring an acceptable form of identification, you will be given temporary access to the test if you can present an ID that includes all of the following: photo, name, R.O.C. identity card number, date of birth. A family member or friend must bring your acceptable form of identification (R.O.C. identity card or valid passport only) to the test site before the end of the test. If your identity can in this way be unmistakably established, you are considered to have entered the test with acceptable ID according to regulations. If this is not the case, your test will not be scored. The test fee will not be refunded, nor can the test be rescheduled.

※ If your name or ID Number on the identification presented on the day of the test does not match the name or ID Number given at the time of registration, you will not be admitted to the test.

※ Please note that it is not possible to change test taker's name after the test. To change your name before the day of the test, you must present a copy of your household registration to certify the name change.

4. The photo provided at the time of registration will be used to confirm your identity on the day of the test. If identification in this way is not possible, you will not be admitted to the test. The test fee will not be refunded, nor can the test be rescheduled.

5. Test time and venue are as indicated on the admission ticket. Test takers are not permitted to request a change in the test time or venue.

6. Please avoid bringing any valuables to the test venue. We assume no liability for lost items. Personal belongings other than those required to take the test must be left outside the testing room in the place indicated by test supervisors. Test takers who do not comply with these regulations will not be permitted to take the test.

7. Please arrive at the testing room 30 minutes prior to the start of the test. No one will be admitted after testing has begun. Before entering the testing room, please consult the seating charts posted at the testing room entrance to find your seat. Be prepared to present your ID upon entry. Anyone who has not entered the testing room when testing begins will not be permitted to take the test.

8. Mobile phones, watches and other electronic devices must be switched off before entering the testing room. Devices

must be completely shut down to ensure they make no sound at all. Devices may be turned on again only after test takers have been dismissed by the test supervisor. Failure to comply with these regulations will result in your test not being scored. The test fee will not be refunded, nor can the test be rescheduled.

9. The test lasts for approximately 2.5 hours without any scheduled breaks. You may not leave the room without permission or hand in the test early. If you absolutely must leave the room, you must seek permission from the supervisor. Any time lost as a result of your absence will not be compensated.

10. The test has two sections, listening and reading. A certain amount of time is allotted for each section. During the allotted time for one section, whether you have completed this section or not, you are not permitted to work on or make changes of any kind in the other section. Failure to comply with these regulations will result in your test not being scored. The test fee will not be refunded, nor can the test be rescheduled.

11. Smoking, drinking, making noise, eating and chewing betel nuts or chewing gum are not permitted in the testing room.

12. If you are found copying test questions or answers, taking notes of any kind, communicating with other test takers or cheating in any other way, your test will not be scored. The test fee will not be refunded, nor can the test be rescheduled.

13. Apart from completing your personal information and marking answers in the columns provided, you may make no other marks on the answer sheet.

14. Test takers must stop working immediately when time is called. Test takers are asked to sit quietly while test materials are collected and accounted for and until they are dismissed by the test supervisor. Any writing after the designated time is considered misconduct and will result in your test not being scored. The test fee will not be refunded, nor can the test be rescheduled.

15. To ensure safety and order, video cameras may be in operation at the test site.

16. Devices with video or audio recording capability may not be brought into the testing room. If a test taker is suspected to be in possession of or using recording equipment while the test is in progress, the test supervisor has the right to demand that test taker render the device and submit to inspection. If test taker refuses to cooperate, the test will not be scored.

17. If on the day of the test, you damage equipment at the test site, interfere with the staff's administration of the test or cause any other kind of disruption, despite having been warned by the staff, you will not be allowed to continue the test and you will be dismissed from the test site.

The local ETS representative has the right to ban you from taking the test for a period of three years.

If as a consequence of your behavior, other test takers have to continue testing under disturbance or are prevented from continuing the test, this constitutes a violation of other test takers rights and interests. In this case, the local ETS representative will be forced to take legal action to protect its own rights and those of the other test takers.

18. Taking the test for someone else or allowing someone to take the test for you will result in a three-year ban from the test for all parties involved. The test administrator reserves the right to take legal action against perpetrators.

19. The TOEIC test is copyrighted property of Educational Testing Service (ETS). Duplicating and disseminating test material without the permission of ETS are strictly prohibited. Any attempt to remove testing material from the testing room or to make video, audio, or any other type of recording will result in a five-year ban from the test. The local ETS representative reserves the right to legal action.
20. If for any reason a test cannot be scored, the test administrator must make appropriate arrangements for a repeat test.
21. If unforeseeable events (natural disaster, strike, demonstration, etc.) prevent testing to proceed as scheduled, the test administrator will announce subsequent arrangements.
22. In case of an epidemic disease or flu, the test administrator will take the necessary measures to ensure the safety of all test takers. Test takers are asked to cooperate with special arrangements or regulations, which may include body temperature measurement at the entrance to the testing room, the use of face masks and sterilizers in the testing room, or the denial of entry for test takers suspected to be carriers of such disease or flu etc.
23. The associated organisations referred to in the TOEIC bulletin and registration form include associated test centers, IT companies, post offices, and others.
24. The test administrator (Chun Shin Ltd.) reserves the right to the final interpretation of each item in these regulations.
